9:30am Chairman McConnell called the meeting to order.

Claims

Claims include the purchase of the new Ambulance. Ambulance is in Boise and all the decals are done and waiting payment.

There is one issue, the tie downs in the build were not changed and they won't fit the new gurneys. Discussion on options.

Systems Design West Billing

Contact that Larrin was working with is no longer there and had to start again with a new contact. Discussion on the request for 2-year term agreement. Discussion on options for wording that is acceptable. E Scott put in some word changes for Larrin to send to Systems Design West for approval.

Still having issues with IRIS Medical and the auditors. IRIS Medical has a policy of writing off accounts that they deem as uncollectable. Auditors picked-up on a discrepancy in the flow of the receivables between the end of December 2014 and January 2015. They cannot provide Larrin with documentation of what has been written off. E Scott will send a letter to them as County Prosecutor.

Larrin has been contacted by Boise High School District requesting donated equipment. We have an old ambulance that they would be interested in. Discussion on old ambulance equipment and what to do with it.

Commissioner Wood made a motion to surplus the 1997 ambulance last VIN# A20733 to donate to the Boise School District. Commissioner Hubert seconded. Discussion on the vehicles. Vote unanimous in favor, motion carries.

Commissioner Hubert made a motion to pay the claims for the Ambulance District in the amount of \$143,913.65, less (\$3.58) difference on a credit on the DL Evans credit card making a total of \$143,910.07. Vote unanimous in favor, motion carries.

Discussion on changing the name of the County Disaster Services to Lincoln County Office of Emergency Management to model the Idaho office change. Agreed to the change.

Discussion on the Emergency Declaration and emergency meeting.

Commissioner Hubert made a motion to ratify the Declaration of Emergency, Lincoln County Resolution 2017-05. Commissioner Wood seconded. Commissioner Hubert read the resolution into the record. According to 46-1011, a disaster can only be declared by the Mayor or the Chairman. Vote unanimous in favor, motion carries.

Commissioner Hubert made a motion to accept the minutes for the Emergency Meeting of February 11, 2017. Commissioner Wood seconded. Vote unanimous in favor, motion carries.

10:45am Claims, Minutes

Commissioner Hubert made a motion to pay the Indigent claims in the amount of \$11,210. Commissioner Wood seconded. Vote unanimous in favor, motion carries.

Commission Wood made a motion to pay the claims for February 13, 2017 in the amount of \$62,844.24. Commissioner Hubert seconded. Discussion. Vote unanimous in favor, motion carries.

Northwinds has given a quote for the additional work and scope. Commissioner Hubert contacted the other Commissioners by phone give approval for the additional work.

Commissioner Hubert made a motion to approve the \$2,284 for additional Northwinds contract scope work. Commissioner Wood seconded. Discussion, good faith reason for moving forward prior to meeting was a financial loss because they were to meet with the BLM the next day. Vote unanimous in favor, motion carries.
