Claims, Minutes

Commissioner Hubert made a motion to pay the Indigent claims for \$471.35. Commissioner Wood seconded. Vote unanimous in favor, motion carries.

10:27am Accident Report – Sheriff

Sheriff Rodriguez reported on the vehicle accident of Deputy White. She is ok, just sore. ISP is still investigating the accident, but will expedite. She was on route on a call for a lockdown at the Shoshone School that had called for County assistance.

Sheriff explained the incident as it unfolded.

11:05am Public Defense Commission-Brianne McCoy

She is required by Statute to meet with the Commissioners every quarter.

First standards from the Commission have to be met by March 2018. She explained the current standards and that the County is currently in compliance with them.

New standards being discussed for 2019.

Public Defense Commissioner to have oversight and enforcement of the standards. Trying to increase the effectiveness of Public Defense.

In 2020 it is projected to have a workload standard. BSU is doing the study and they have a consultant checking methodology. When that is in place, it is up to the Counties to ensure we are in compliance.

New Grant application forms will be out February 28^{th} and they will be due in to the Commission by May 1^{st} .

11:30am Reimburse for Spring Flooding

Commissioners called John from the City and discussed the expenses they incurred. Bulk water is charged out at \$3 per 1,000 gallons.

Discussion on how much to donate and what they contributed. Discussion on what the BLM contributed. Discussion on the fine that was paid was specifically for the water contamination caused by the dairy and we should help those who were directly involved with that incident.

Commissioner Hubert made a motion to donate the City \$5,000 and the Fire District \$10,000 and the remaining money to the general fund. Chairman McConnell called for a second. Motion failed for a lack of second.

Commissioner Wood made a motion that out of the \$60,000 fine that came from the Dairy, \$30,000 be split with the Shoshone Fire, Shoshone City and County and the other \$30,000 be put in the general fund to be used later for a County improvement project. Chairman McConnell seconded. Discussion; Commissioner Hubert feels that it should not be earmarked but should go directly into the general fund without earmarking. Discussion with the Prosecutor on the proper process. Vote unanimous in favor, motion carries.

12:01pm Chairman McConnell adjourned the meeting for lunch at the Care Center.

1:03pm Chairman McConnell called the meeting to order. Ray McClure and Larry Kerner were present

Adopt Resolution 2018-01 Commissioner Districts

Commissioners were presented with a statement of objection on the record from Don Hudson and the Lincoln County Concerned Citizens Committee.

Questions were answered from the floor about the process and the how the current boundaries were arrived at. Also went through the legal descriptions by following the map.

Commissioner Wood made a motion to accept Resolution 2018-01, Adopt Commissioners Districts. Commissioner Wood read the Resolution into the record. Commissioner Hubert seconded. Discussion again on boundaries with patrons. Vote unanimous in favor, motion carries.

1:45pm Worst, Fitzgerald and Stover agreement

Commissioner Wood made a motion to approve the agreement with Worst, Fitzgerald and Stover as presented. Commissioner Hubert seconded. Discussion, this is for legal action taken against Chairman McConnell's residency. Vote unanimous in favor, motion carries.

Discussion on information from Sally Toone from the State Emergency Management and she asked why the Highway Districts in Lincoln County didn't apply. They have re-opened the application process for a limited number of weeks.

Discussion on the request for Lincoln County Commissioner to give testimony at a legislative hearing on the Ambulance District levy during the first week of February.
